4. Member New Business

4.1 Update on bargaining

Bargaining continues, the next meeting is January 15, 2021. We have 180 days to complete negotiations before arbitration. When the contract is agreed upon, it will be brought to union members to ratify. Changes will be retroactive beginning July 1, 2020. 4.2 Bob Estabrook, Government Relations Specialist (PERS)

Bob discussed the redirect details from PERS. If you exceed 2500.00 gross income in a single month, the following percentages will be redirected. Tier One 2.5%, Tier Two 2.5% and OPSRP .75%. If the district reports payroll over 12 months, this could potentially be better if you do not gross over 2500.00 monthly. If you qualify for unemployment benefits, a 12 month pay period will not affect unemployment benefits. This will be a long, legislative session, more news to come. ***See attached Senate Bill 1049 IAP redirect FAQ.

This would give you a better pay check during those months. Any vacation days left at the end of the school year will be paid out to you.
